to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Lide L. Richbourg, his heirs and assigns forever:

All that certain piece, parcel or lot of land, with the buildings and improvements thereon, lying and being on the westerly side of Townes Street Extension, and being designated as Lot No. 4 and . part of Lot No. 3, Block H, of Highland Terrace as recorded in the RMC Office for Greenville County, S. C. in Plat Book K, pages 120, 121 and 122, and having according to a survey made by R. W. This deed is given simultaneously with a deed from the grantee herein to the grantor herein to correct errors previously made in two conveyances by J. H. Mauldin. By deed dated May 13, 1952 and recorded May 15, 1952, in the RMC Office for Greenville County, in Deed Book 456, page 177, Lucy L. Hindman conveyed to J. H. Mauldin Lots 1, 2, 3 and 4, Block H, Highland Terrace, on the west side of Townes Street Extension. By deed dated November 6, 1952, and recorded December 5, 1952, in Deed Book 468, page 47, J. H. Mauldin conveyed to James P. Yonce Lot No. 1 and the adjoining 16 feet, 8 inches of Lot No. 2. Subsequently, James P. Yonce conveyed this same property to Lide L. Richbourg by deed dated June 6, 1957, recorded June 7, 1957, in Deed Book 578, page 199. The said Lide L. Richbourg is the present owner of said property in fee simple title, subject to the lien of the mortgage given by James P. Yonce to First Federal Savings and Loan Association, dated November 6, 1952, in the original amount of Nine Thousand and no/100 (\$9,000.00) Dollars, and recorded in Mortgage Book 547, page 284.

By deed dated January 31, 1953 and recorded on February 2, 1953, in Deed Book 471, page 297, the said J. H. Mauldin did convey to Walter L. Jackson, Jr. Lot No. 4 and the adjoining 17 feet of Lot No. 3. The said Walter L. Jackson, Jr. is the present owner of said property in fee simple title, subject to the lien of the mortgage given by him to C. Douglas Wilson & Co. dated January 31, 1953, in the original amount of Ninety-five hundred and no/100 (cont'd on reverse side) TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging. or in anywise incident or appertaining.
