BEGINNING at an iron pin on the southern side of Marchant Street at the joint front corner of Lots Nos. 6 and 7 and running thence with the line of Lot No. 6 S. 25-52 E. 276.4 feet to an iron pin in the line of Lot No. 3; thence with the line of Lot No. 3 N. 74-13 E. 53 feet to an iron pin at the joint rear corner of Lots Nos. 7 and 8; thence with the line of Lot No. 8 N. 18-13 W. 282.3 feet to an iron pin on the southern side of Marchant Street; thence with the Southern side of Marchant Street S. 67-55 W. 90 feet to the point of beginning.

This conveyance is made subject to restrictive covenants applicable to Monaghan Bubdivision recorded in the R.M.C. Office for Greenville County in Deed Book 509 at page 443, and to an easement for utilities service dated October 11, 1954, given by J. P. Stevens & Co., Inc., to Duke Power Company and recorded in the R.M.C. Office for Greenville County in Deed Book 510 at page 317.
