Gilstrap, his heirs and assigns forever, my one-half interest in,

All that parcel, piece or lot of land with the buildings and improvements thereon, situate, lying and being in the city and county of Greenville, State of South Carolina, on the West side of Sitka Avenue and known and designated as Lot #20 of Parkview, a plat of which is recorded in the R. M. C. Office for Greenville County in Plat Book "M" at page 49 and having according to said plat the following metes and bounds, courses and distances to-wit:

BEGINNING at an iron pin on the West side of Sitka Avenue, which iron pin is 110.5 feet South of the Southwestern intersection of Haviland and Sitka Avenues (this point is taken from projecting the lines of the two avenues since the intersection is a curve instead of a corner), joint corner of Lots #20 and 21, and running thence along the joint line of said lots S. 63-45 W. 150 feet to an iron pin in the line of Neely Drive (which iron pin is 82 feet from the South-eastern intersection of Haviland Avenue and Neely Drive), thence along the line of Neely Drive S. 26-15 E. 50 feet to an iron pin, rear joint corner of Lots #19 and 20, thence along the joint line of said lots N. 63-46 E. 150 feet to an iron pin in the line of Sitka Avenue, thence along the line of Sitka Avenue N. 26-15 W. 50 feet to the point of beginning.

The above property is sold subject to the restrictions recorded in the R. M. C. Office for Greenville County in Deeds, Volume 245 at page 138, on June 6, 1942.
