Davis, her heirs and assigns forever:

-That certain lot or parcel of land, with any improvements thereon, in the City of Greer, School District 285, Chick Springs Township, said County of Greenville, and said State, designated as Lot # 1 on plat prepared by H. S. Brockman, Surveyor, January 3, 1936, of the property of H. M. Satterfield, formerly T. B. Snow Estate, and bounded as follows:
