ALL that piece, parcel or lot of land in the County of Greenville, State of South Carolina, being known and designated as LOT NO. 5 on Mills Avenue according to a plat of the Subdivision known as KIRKWOOD HEIGHTS made by Pickell & Pickell, Engrs., October 1954 and recorded in the RMC Office for Greenville County in Plat Book EE, at pages 110 and 111 and having the following metes and bounds, to wit:

BEGINNING at an iron pin at the joint front corner of Lots 4 and 5 on Mills Avenue and running thence along the joint line of said lots, North 17-56 West 150 feet to an iron pin; running North 72-04 East 75 feet to an iron pin; running thence South 23-39 East 150.7 feet to an iron pin on Mills Avenue; running thence along Mills Avenue, South 72-04 West 90 feet to the point of beginning.
