Palm and Beatrice F. Palm the following-described property:

ALL That certain piece, parcel or lot of land situate, lying and being in the County of Greenville, State of South Carolina, being known and designated as Lot No. 4 and one-half of Lot No. 5 on plat of "Pinehurst" prepared by Dalton & Neves, Engineers, dated August 1955, recorded in the Office of the R. M. C. for Greenville County, South Carolina in Plat Book PP, Page 38, and having according to said plat the following metes and bounds, to-wit:

BEGINNING At an iron pin on the western side of Paris View Drive at the joint front corner of Lots 3 and 4, and running thence along the joint line of said lots, S. 89-02 W. 320 feet to an iron pin in line of property of Casa Loma Estates; thence along line of said property, N. 19-34 W. 95 feet to an iron pin, joint rear corner of Lots 4 and 8; thence along the rear line of Lots 7 and 8, N. 89-02 E. 171 feet to an iron pin, joint rear corner of Lots 5 and 7; thence along the rear line of Lot 5, N. 0-58 W. 50 feet to a point in the center of said rear line of Lot 5; thence along the center of said lot, N. 89-02 E. 180 feet to a point on the western side of Paris View Drive; thence along the western side of Paris View Drive, S. 0-58 E. 140 feet to the point of beginning.
