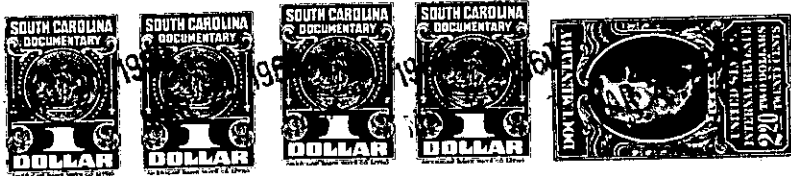
Greenville in the State of South Carolina, for and in consideration of the

sum of One Thousand Eight Hundred Fifty and No/100ths (\$1,850.00)----- dollars, to it in hand duly paid at and before the sealing and delivery of these presents by the grantee(s) hereinafter named, (the receipt whereof is hereby acknowledged), has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto WILLIAM C. MATTHEWS:

All that piece, parcel or lot of land situate, lying and being in the County of Greenville, State of South Carolina, being known and designated as Lot No. 55 as shown on Plat No. Three, Cherokee Forest, prepared by J. Mac Richardson; R.L.S., in January, 1959, and recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book QQ at pages 36 and 37, and having according to said plat the following metes and bounds:

BEGINNING at an iron pin on the Southern side of Roberta Drive at the joint front corner of Lots Nos. 54 and 55, and running thence with the line of Lot No. 54 S. 15-58 W. 214.6 feet to an iron pin in the line of property now or formerly of Cunningham; thence with the line of the said Cunningham property N. 73-45 W. 100 feet to an iron pin at the joint rear corner of Lots Nos. 55 and 56; thence with the line of Lot No. 56 N. 15-58 E. 214 feet to an iron pin on the Southern side of Roberta Drive; thence with the Southern side of Roberta Drive S. 74-02 E. 100 feet to the point of beginning.
