All that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina: That certain lot or parcel of land lying and being situate on the North side of the Buncombe Road near the village of Travelers Rest in the County and State aforesaid in a subdivision known as "Love Estates" as shown on a plat in the office of the R. M. C. for Greenville County in Plat Book I, at pages 111 and 112 and being known and designated as lot 39, and having the following courses and distances, to wit:
