All that certain piece, parcel or lot of land, situate, lying and being in the County of Greenville, State of South Carolina, in the Town Limits of Travelers Rest and known and designated as Lot No. 3 on plat of the estate of Maggie Love Howard, made by Terry T. Dill, April 6, 1960 and having, according to said plat, the following metes and bounds, to-wit;
