

All that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, situate, lying and being on the eastern side of Westview Avenue in the City of Greenville and being known and designated as Lot No. 9, Block "L" of Section B of Parkvale, as shown on plat thereof recorded in the R. M. C. Office for Greenville County in Plat Book "K", Page 53 and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the eastern side of Westview Avenue, joint front corner of Lots Nos. 9 and 10, and running thence along the line of Lot No. 10, S. 89-30 E. 175 feet to an iron pin, joint corner of Lots Nos. 6, 5, 9 and 10; thence with the line of Lot No. 6, N. 4-00 E. 75 feet to an iron pin, joint corner of Lots Nos. 6, 7, 8 and 9; thence with the line of Lot No. 8, N. 89-30 W. 175 feet to an iron pin on the eastern side of Westview Avenue, joint front corner of Lots Nos. 8 and 9; thence with the eastern side of Westview Avenue, S. 4-00 W. 75 feet to the beginning corner.
