to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said grantee(s)

C. H. Bagwell, his Heirs and Assigns forever,

All that certain piece, parcel or lot of land situate, lying and being in the State and County aforesaid, Butler Township, in the Rocky Creek Community, lying on the west side of the Roper Mountain Road, being bounded on the east by the said Roper Mountain Road, on the south by other lands of myself, and on the west by a tract of 6.84 acres being conveved this day to the grantee herein by 0. H. Bagwell, and being a part of the same land conveyed to me by deed from Marjorie Bagwell December 10th 1945, recorded in office of the R. M. C. for Greenville County in Deed Book 285 at page 68, and having the following courses and distances, to wit:-

Beginning on an iron pin, joint corner of the 6.84 acre tract, and runs thence with the line of the 6.84 acre tract, S. 41-34 E. 338 feet to an iron pin, joint corner of the said tract; thence N. 48-26 E. 141 feet to a nail and cap in the center of the Roper Mountain Road (iron pin back on line at 22 feet); thence with the said Road, N. 58-12 W. 322.3 feet to a nail and cap in the denter of the said road; thence S. 79-25 W. 57 feet to the beginning corner, containing Sixty Nine One-hundredths (0.69) of one acre, more or less.
