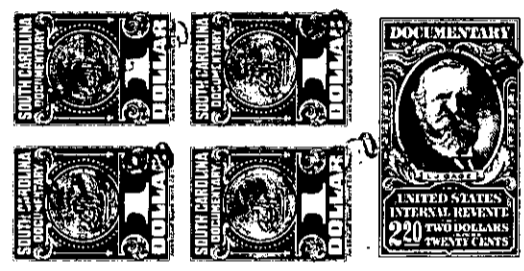

LEWIS STOVER, His Heirs and Assigns:

ALL that certain piece, parcel or lot of land in Butler Township, Greenville County, State of South Carolina, near the City of Greenville, and being known and designated as Lot Number 103 of a subdivision known as McSwain Gardens, a plat of which is of record in the R. M. C. Office for Greenville County in Plat Book GG at Page 75, and having the following metes and bounds, to wit:

BEGINNING at a point on the Eastern side of McSwain Drive at the joint front corner of Lots 102 and 103 and running thence N 64-19 E 175 feet to a point at the joint rear corner of Lots 102 and 103; thence S 22-23 E 100 feet to a point at the joint rear corner of Lots 103 and 104; thence S 64-19 W 175 feet to a point on the Eastern side of McSwain Drive at the joint corner of Lots 103 and 104; thence with the Eastern side of McSwain Drive N 22-23 W 100 feet to the point of beginning.
