

All that piece, parcel or lot of land, with improvements thereon, in Greenville County, State of South Carolina, in Ward 2, City of Greenville, and being known and designated as Lot No. 3 of the property of Griffin, et al., as per plat of said property by Dalton and Neves, Engineers, made October, 1930. Said lot is more particularly described as follows: BEGINNING at an iron pin on the west side of East North Street, 140.7 feet north of the northwest corner of East North Street and Richland Avenue, and running thence N. 77-03 W., 163.4 feet to an iron pin on the line of Lot No. 25; thence N. 40-41 E., 70.3 feet to an iron pin, joint corner of Lots Nos. 3, 4 and 25; thence S. 77-03 E., along line of Lots Nos. 3 and 4, 150 feet to an iron pin on East North Street; thence S. 12-57 W., 35 feet to bend in street; thence S. 6-24 W., 35 feet to the point of beginning.
