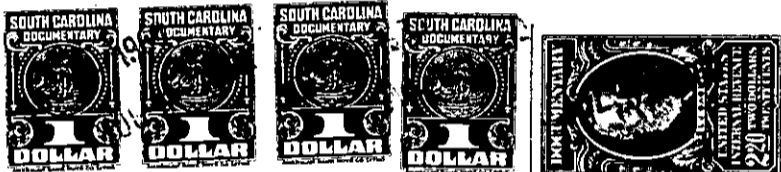
Know All Men by These Presents:

ALL that piece, parcel or lot of land situate, lying and being off the Eastern side of the Old Buncombe Road, in a subdivision known as Casa Loma Estates, being shown as Lot No. 29, on Plat of Casa Loma Estates made by Piedmont Engineering Service in October, 1947, said plat recorded in the R. M. C. Office for Greenville County in Plat Book S, at Page 65.

BEGINNING at an iron pin on Courtney Circle, joint front corners of Lots Nos. 28 and 29 and running thence along the line of said lots, S. 82-22 E. 183.7 feet to an iron pin; thence running with rear line of Lot 29, N. 19-10 E. 116.9 feet to an iron pin; thence running, N. 64-36 W. 60.7 feet to iron pin rear corner of Lot 30; thence running with line of said lot, S. 79-21 W. 182.3 feet to iron pin on Courtney Circle; thence running with Courtney Circle S. 19-34 E. 41.9 feet to an iron pin; thence running S. 0-12 E. 39.9 feet to an iron pin at point of beginning.
