OF
GENERAL POWER OF ATTORNEY

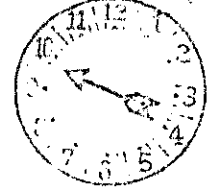

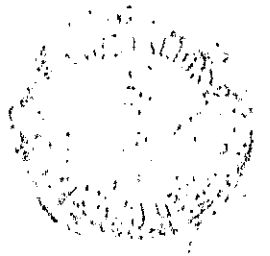
