FIRST: That their names and residences are as above given.

SECOND: That the name of the proposed corporation is JACK E. SHAW BUILDERS, INC.

THIRD: That the principal place of business is GREENVILLE, S. C.

FOURTH: That the general nature of the business which it is proposed to do is to engage in the general contracting business or contract basis and to buy, sell, rent, lease real estate and to do all other things legally authorized for corporations in the State of South Carolina.

FIFTH: That the amount of the capital stock is Twenty -five Thousand (\$25,000.00)-------Dollars payable Twelve Thousand Five Hundred (\$12,500.00) dollars cash or securities valued at Twelve Thousand Five Hundred (\$12,500.00) Dollars.

NINTH: That all requirements of Title 12, Article 1, Chapter 2, Code of Laws of South Carolina, 1952, and all amendments thereto have been duly and fully complied with, 50 per cent. of the aggregate amount of the capital stock having been subscribed by bona fide subscribers, 20 per cent. of the capital stock subscribed having been paid to the Treasurer, and three days' public notice of the intention to file this Declaration with the Secretary of State having been given in the Greenville Piedmont
