in consideration of the sum of Two Thousand (\$2,000.00) in the State aforesaid, and assumption of mortgage to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Reuben Edward Williams and Mary K. Williams,

All that piece, parcel or lot of land in the County of Greenville, state of South Carolina, designated as Lot No. 13, Block "C" on a revised plat of a portion of Block "C" of BROOKFOREST subdivision, made by Dalton & Neves, November 1956, recorded in Plat Book LL page 188 of the RMC Office for Greenville County, S. C., and having according to said plat and a recent survey made by R. W. Dalton, February 1957, the following metes and bounds, courses and distances, to-wit:

Beginning at an iron pin on the southwest side of Westbrook Lane, the front joint corner of Lots Nos. 13 and 14; thence with the joint line of said lots, S. 43-39 W. 183 feet to an iron pin in line of Lot No. 20; thence with the line of said lot, S. 54-05 E. 48 feet to an iron pin, corner of Lot No. 12; thence with the line of said lot, N. 55-42 E. 175 feet to an iron pin on the southwest side of Westbrook Lane; thence with the southwest side of said Westbrook Lane, N. 42-53 W. 85 feet to the beginning corner.

This is the same property conveyed to grantor by Milton R. Lillard, by deed recorded February 13, 1959 in volume 617 page 26 of the RMC Office for Greenville County.

The grantees herein assume and agree to pay that certain mortgage held by C. Douglas Wilson & Co. (assigned to Life Insurance Company of Georgia) recorded in book 706 page 395 of the RMC Office for Greenville County, on which there is a balance due of \$12,480.32.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining.

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and their Heirs and Assigns forever.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s) Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s) Heirs and Assigns against the grantor(s) and the grantor's(s) Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
