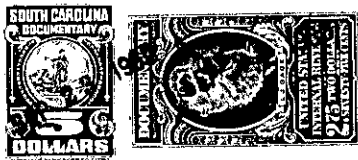

All that certain piece, parcel or lot of land situate, lying and being in Chick Springs Township, Greenville County, State of South Carolina, being known and designated as Lot No. 49 as shown on a plat of "Rosedale", revised May and June, 1960, prepared by C.O. Riddle, R.L.S., recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book QQ at page 113, and having according to said plat the following metes and bounds:

BEGINNING at an iron pin on the Southern edge of Rosemary Lane at the joint front corner of Lots Nos. 48 and 49, and running thence with the Southern edge of Rosemary Lane S. 73-52 E. 110 feet to an iron pin with the joint front corner of Lots Nos. 49 and 50; thence with the line of Lot No. 50 S. 16-08 W. 150 feet to an iron pin; thence N. 73-52 W. 110 feet to an iron pin at the joint rear corner of Lots Nos. 48 and 49; thence with the line of Lot No. 48 N. 16-08 E. 150 feet to the point of beginning.
