to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipts whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said ARTHUR E. DAVIDIAN AND LILLIAN DAVIDIAN, Their heirs and assigns forever:

All that certain piece, parcel or lot of land situate, lying and being in Chick Springs Township, County and State aforesaid, known and designated as Lot No. 38 on a Plat of "Rosedale", Revised May and June, 1960, prepared by C. O. Riddle, R.L.S., and having, according to said Plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the North side of Rosemary Lane at the joint front corners of Lots 39 and 38 and running thence along Rosemary Lane S. 73-52 E., 108 feet to an iron pin, the joint front corner of Lots 38 and 37; Thence continuing along the joint line of Lot 38 and 37 N. 16-08 E., 150 feet to an iron pin the joint rear corner of Lots 38 and 37; Thence continuing N. 73-52 W. 108 feet to an iron pin, the rear joint corner of Lots 38 and 39; Thence S. 16-08 E., 150 feet along the common line of Lots 39 and 38 to the point of beginning.
