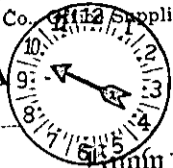

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipts whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said M. W. Fore, his heirs and assigns, forever:

ALL that piece, parcel or lot of land in Gantt Township, Greenville County, State of South Carolina, being known and designated as lot 59 Buffalo Drive, in Section C of Englewood Estates, as shown by a plat thereof, dated December 1951, recorded in the R. M. C. Office for Greenville County, S. C. in Plat Book BB at page 13, and having the following metes and bounds: "

BEGINNING at an iron pin on the east side of Buffalo Drive, at joint front corners of lots 58 and 59 and running N. 2-30 E. 75 feet to an iron pin on Buffalo Drive at joint front corners of lots 59 and 60; thence with the common line of lots 59 and 60 S. 87-30 E. 200 feet to an iron pin at the rear corners of lots 59 and 60; thence S. 2-30 W. 75 feet to an iron pin at the rear corners of lots 59 and 58; thence with the common line of lots 59 and 58 N. 87-30 W. 200 feet to an iron pin on Buffalo Drive, the point of beginning.

Restrictions: The above described property is not to be sold, rented or otherwise disposed of to any Negro or person of African descent. No residence shall be built for less than \$5000.00. No residence shall be erected nearer than 50 feet to the front line nor shall any residence be erected on said lot unless it have 50 feet, or more, frontage. No temporary dwelling shall be erected on said lot.

GRANTEE herein to pay taxes for the year 1960.

This property is conveyed subject to any rights-of-way now in existence.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining.

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named and his Heirs and Assigns forever.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s') Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s') Heirs and Assigns against the grantor(s) and the grantor's(s') Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
