in consideration of the sum of Four Thousand Six Hundred Fifty and no/100 -----DOLLARS,

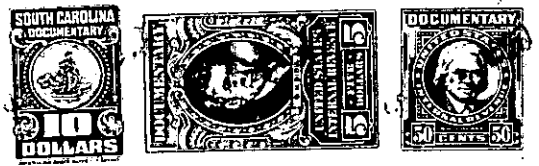

ALL that certain piece, parcel or lot of land situate, lying and being on the East side of a County Road, near the City of Greenville, in Chick Springs Township, in Greenville County, S.C., having according to a survey made by Pickell & Pickell, Engineers, October 30, 1950, the following metes and bounds, to-wit:
