in consideration of the sum of Five Hundred Fifty-four and 15/100 - (\$554.15) - - DOLLARS, in the State aforesaid, to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Thomas K. Johnstone, Jr., his heirs and assigns:

All of my right, title and interest, the same being an undivided one-twelfth (1/12) interest in and to all that piece, parcel or tract of land situate on the eastern side of the White Horse Road and according to plat of property of Julia A. Walker Estate, recorded in Plat Book PP, Page 47, having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the eastern side of the White Horse Road, at the corner of the Screw Company property, and running thence S. 87-59 E., 540.1 feet to an iron pin; thence S. 2-30 W., 219.1 feet to an iron pin; thence S. 88-41 E., 102 feet to an iron pin; thence due north 393.6 feet to an iron pin; thence N. 84-30 W., 533 feet to an iron pin on the eastern side of White Horse Road; thence with said Road, S. 24-05 W., 229.3 feet to the point of beginning, and being the tract marked "James" on the above mentioned plat, and containing 3 acres, more or less.
