TIMMONS, JR., in the State aforesaid, in consideration of the sum of ONE THOUSAND NINE HUNDRED SEVENTY AND NO/100----- DOLLARS, (\$1,970.00) to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipts whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said C. OTTO WHITE, JR., REALTOR, His Heirs and Assigns:

ALL that certain piece, parcel or lot of land in Butler Township, Greenville County, State of South Carolina, near the City of Greenville, and being known and designated as Lot Number 56 of a subdivision known as McSwain Gardens, a plat of which is of record in the R. M. C. Office for Greenville County in Plat Book GG at Page 75, and having the following metes and bounds, to wit:

BEGINNING at a point on the Northern side of Shadydale Court at the joint corner of Lots 56 and 57 and running thence N 28-04 W 181.5 feet to a point at the joint rear corner of Lots 56 and 57; thence S 71-20 W 133.6 feet to a point on the Eastern side of McSwain Drive at the joint corner of Lots 56 and 61; thence with the Eastern side of McSwain Drive S 16-25 E 67.8 feet to a point; thence continuing with the Eastern side of McSwain Drive S 30-21 E 109 feet to a point; thence following the curvature of the Northeastern intersection of Shadydale Court with McSwain Drive (the chord of which is S 73-43 E 36.4 feet) to a point; thence with the Northern side of Shadydale Court N 63-15 E 115 feet to the point of beginning.

THIS deed is executed subject to existing and recorded restrictions and rights-of-way.
