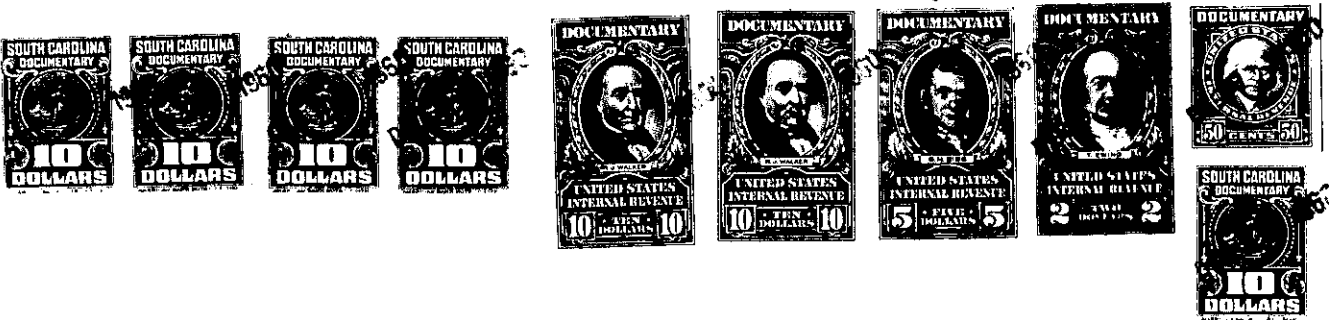
in consideration of the sum of Twenty-four Thousand Seven Hundred Fifty (\$24,750) DOLLARS,
