For and in consideration of the sum of Seventy Five and No/100 (\$75.00) Dollars, lawful money of the United States, paid to the Plaintiff by Laurie Farr Moseley, et al, the below described real property in Greenville County, State of South Carolina, owned by the Defendant in this action, Lawrence M. Eckman, Jr., is hereby wholly released from the lien of that certain judgment filed in the office of Clerk of Court in Judgment Roll H-8119 rendered in the County Court of the County of Greenville, State of South Carolina, on the 6th day of January, 1960, in favor of Temco Employees Credit Union, a corporation, Plaintiff in said action against Defendant Lawrence M. Eckman, Jr. for One Thousand Five Hundred Ten and 11/100 (\$1,510.11) Dollars. and interest and cost, and 20% attorney's fee; and the said Temco Employees Credit Union hereby authorizes and requests the R.M.C. and the Clerk of the County Court, Greenville County, State of South Carolina, to enter this release of the lien of said judgment on all that

CERTAIN piece, parcel or lot of land, situate, lying and being in Butler Township, Greenville County, State of South Carolina, within the corporate limits of the City of Greenville, being shown and designated as Lot No. 10 of a Subdivision known as Hutton Court, a plat of which is on record in the R.M.C. Office of Greenville County, South Carolina, in Plat Book "NN", at Page 101.

BEGINNING at a point on the Eastern side of Hutton Court at the joint front corner of Lots No. 10 and No. 11 and running thence N. 73-39 E. 173.9 feet to a point at the joint rear corner of Lots No. 10 and No. 11; thence running N. 20-08 W. 65.15 feet to a point at the joint rear corner of Lots No. 9 and No. 10; thence running S. 73-39 W. 153.2 feet to a point on the Eastern side of Hutton Court at the joint front corner of Lots No. 9 and No. 10; thence following the curvature of a turn-around at the Northern end of Hutton Court S. 30-37 W. 22.5 feet to a point; thence running with Eastern side of Hutton Court S. 16-21 E. 49.7 feet to the point of beginning.

This being the same property as was conveyed to the Defendant herein by deed of J. P. Medlock, recorded in the R.M.C. Office of Greenville County, South Carolina, in Deed Book 606, at Page 143, on the 12th day of September, 1958.
