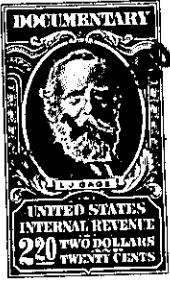

KNOW ALL MEN BY THESE PRESENTS, That LUCINDA L. REID, EVA G. LOCKHART,  
DOSHA L. ROLLINS, TED LOCKHART, MARY EFFIE LOCKHART, DAVE LOCKHART, CHARLES  
LOCKHART, NECIE E. LOCKHART,

in the State aforesaid, in consideration of the sum of  
Nineteen Hundred Twenty-five and no/100 ----- Dollars

to ..... us ..... in hand paid at and before the sealing of these presents  
by The City of Greenville, S. C. ....

(the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these  
presents do grant, bargain, sell and release unto the said THE CITY OF GREENVILLE, S. C.,  
its successors and assigns forever:

ALL that piece, parcel or tract of land situate, lying and being in  
Glassy Mountain Township, Greenville County, State of South Carolina,  
containing 65.5 acres, more or less, and having according to a plat  
of property belonging to Mrs. J. P. Lockhart made by H. B. Frankenfield,  
Jr., Surveyor, on June 11, 1955, the following description:

BEGINNING at a large C.O. 3x in or near Ballew Mill Creek and running  
thence S. 38-45 W. 23.40<sup>24</sup> chains to a C.O. 3x near a large rock; thence  
S. 20-15 E. 7.50<sup>23</sup> chains to a big dead Chestnut 3x, William Plumley's  
corner; thence N. 81-30 E. 15.30<sup>02</sup> chains to a C.O. at foot of Rock  
Boulder; thence S. 65 E. 8.40<sup>52</sup> chains to a Hickory at top of cliff;  
thence N. 64-30 E. 21.80<sup>13</sup> chains to a Black Gum 3x in or near Ballew  
Mill Creek; thence running along the center of Ballew Mill Creek in  
a generally north and northwestern direction to the point of beginning.

This is the same property conveyed to David Lockhart by deed of John  
M. Burnett dated February 9, 1878, and recorded in the RMC Office for  
Greenville County in Deed Book 12, at page 192. The Grantors herein  
are heirs at law of the said David Lockhart. The property herein was  
conveyed to Necie E. Lockhart by deed of John P. Lockhart, etc.,  
dated July 1, 1937, and recorded in the said RMC Office in Deed Book  
226, at page 216.
