All that certain piece, parcel or lot of land situate, lying and being in the State and County aforesaid, Chick Springs Township, in the City of Greer, S. C., Lying on the south side of U. S. Super Highway No. 29, and being a small triangle cut out of Lot No. 7 as shown on Plat of property of W. Dennis Smith and H. J. Waters, said plat recorded in the office of the R. M. C. for Greenville County in Plat Book "Y" at page 69, and having the following courses and distances, to wit:-
