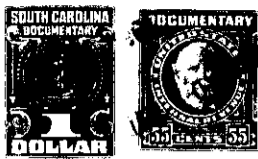

Bowling, his heirs and assigns, forever:

all that piece, parcel or lot of land in Bates Township, Greenville County, State of South Carolina, containing 1.64 acres as shown on plat made by Terry T. Dill, December 1, 1956, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the South side of a County Road, corner of property of the grantee and running with said property line S 19-30 W 435.7 feet to an iron pin in line of property of Euzelia S.
