

All that piece, parcel and lot of land, situate, lying and being on the south-eastern side of Mills Avenue, in the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot No. 32, as shown on a plat prepared by Dalton & Neves, Engineers, dated June, 1937, entitled "Langley Heights" recorded in the R.M.C. office for Greenville County, South Carilina in Plat Book N at pages 132 and 133, and having according to said plat the following metes and bounds:
