

All that piece, parcel or lot of land lying and being situate on the Westerly side of Daisy Drive in Gantt Township, near the City of Greenville, in the County of Greenville, State of South Carolina, being known and designated as Lot No. 74, according to plat of Pine Hill Village, prepared by R. K. Campbell, Surveyor, November 30, 1960, as recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book "QQ" at page 169, and having according to said plat the following metes and bounds, to wit:

BEGINNING at an iron pin on the westerly side of Daisy Drive at joint front corner of Lots 74 and 75, said pin being 50 feet in a northerly direction from iron pin on the westerly side of Daisy Drive in the northwest corner of the intersection of said Daisy Drive and Kennedy Drive and running thence along the joint line of said lots N. 79-11 W. 140 feet to an iron pin at joint rear corner of Lots 74 and 75; thence N. 10-49 E. 70 feet to an iron pin at joint rear corner of Lots 73 and 74; thence along the joint line of said lots S. /9-11 E 140 feet to an iron pin on the westerly side of Daisy Drive; thence along said Daisy Drive S. 10-49 W. 70 feet to an iron pin at joint front corner of Lots 74 and 75, the point of beginning.

The herein named grantee is to pay the 1961 taxes on the above described property.
