All that certain piece, parcel or lot of land situate, lying and being in Gantt Township, County of Greenville, State of South Carolina, being known and designated as Lot No. 12 as shown on a plat prepared by J.C. Hill, L.S., dated February 12, 1960, entitled "Property of Otis Davis", recorded in the R.M.C.
