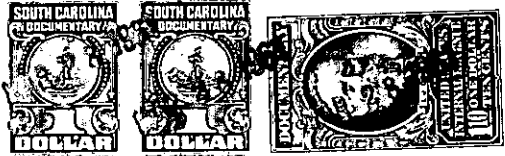
WILLIAM M. HENDRIX, His Heirs and Assigns:
