Glynn A. Lindsey, his heirs and assigns forever:

All that lot of land in the County of Greenville, State of South Carolina, known as lot 172 of Paramount Park, recorded in the R. M. C. Office for Greenville County in plat book W at page 57, and having, according to said plat, the following metes and bounds, to-wit:

Beginning at an iron pin on the northwestern side of Crosby Circle, 125 feet southwest of Mayo Drive, at the center of a 10-foot strip reserved for utilities, which iron pin is a joint front corner of lots 173 and 172, and running thence N 26 W, 150 feet to an iron pin at the rear corner of lot 176; thence S 64 W, 70 feet to an iron pin in the line of lot 171, ~~which iron pin is also located in the center of a 10-foot strip~~, and running thence ~~along the center of said strip along the line of lots 172 and 173~~, S 26 E, 150 feet to an iron pin, joint front corner of lots 172 and 171; thence along the northwestern side of Crosby Circle N 64 E, 70 feet to the point of beginning, and being the same property conveyed to me in deed book 456 at page 295.
