Clayton, L.S. No. 1836 dated

the 26th of November 1960 to-wit: Commencing at the Northeastern corner an iron pin on edge of right of way of road and running thence North 76-30 West 290 feet to I.P. 3x in pines. thence South 29-00 West 150 feet to iron pin 3x in pines thence South 76-30 East 290 feet to iron pin and stone on edge of road, thence with Western edge of road North 29-00 East 150 feet to I.P. the point of beginning. Said plat shows the Northeastern I.P. to be 60 feet distant from an old iron pin on the Eastern side of the road and the Southeastern corner to be 104.5 feet distant from the said old iron pin.
