the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Albert C. Gilliland and Essie R. Gilliland, their heirs and assigns forever:

ALL that piece, parcel or lot of land in Gantt Township, being known and designated as Lot No. 54, of a subdivision known as Bel Aire Estates, as shown on a Plat thereof dated May 1956, recorded in the R. M. C. Office for Greenville County in Plat Book KK, at Page 19, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on Sangamo Drive, joint front corners of Lots Nos. 54 and 55 and running thence along the line of said lots, S. 4-30 E. 190 feet to iron pin line of Lot 57; thence running with line of said lot, S. 85-30 W. 72 feet to iron pin rear line of Lot 5; thence running with rear line of Lots 5, 4, 3, N. 4-30 W. 190 feet to iron pin on Sangamo Drive; thence running with said Drive, N. 85-30 E. 72 feet to iron pin at point of beginning.

NO residence to cost less than Seven Thousand Five Hundred (\$7,500.00) Dollars shall be erected on said lots; no residence shall be erected on any lot unless said lot has fifty (50) feet or more frontage; no residence shall be built on any lot nearer than thirty (30) feet to the front line; no outside toilets permitted and sewage to be disposed of by approved septic tanks; no business buildings shall be erected on any lot other than lots fronting on Staunton Bridge Road.

THIS conveyance is subject to all easements and rights of way of record.
