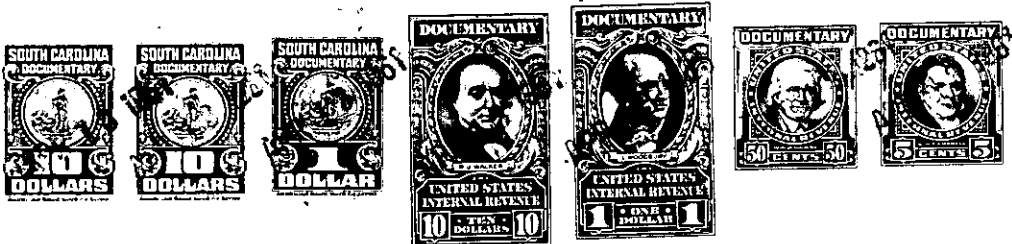

All that certain piece, parcel or lot of land situate, lying and being in Gantt Township, County of Greenville, State of South Carolina, being known and designated as Lot No. 9 as shown on a plat prepared by J.C. Hill, L.S., February 12, 1960, entitled "Property of Otis Davis", recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book TT at page 161, and having according to said plat the following metes and bounds:

BEGINNING at an iron pin on the Northwestern side of Maurty Street at the joint front corner of Lots Nos. 9 and 10, and running thence with the line of Lot No. 10 N. 34-10 W. 120 feet to an iron pin on the subdivision property line; thence with the subdivision property line S. 54-35 W. 70.3 feet to an iron pin at the joint rear corner of Lots Nos. 8 and 9; thence with the line of Lot No. 8 S. 35-55 E. 120 feet to an iron pin on the Northwestern side of Maurty Street; thence with the Northwestern side of Maurty Street N. 54-35 E. 65 feet to the point of beginning.
