

The location of the center of the said pipe line or lines as the said pipe line or lines pass through the property of Sallie Hood will be as follows:

Entering the North boundary line of the property of Sallie Hood at a point in a creek which point is 475 feet, more or less, in a Western direction from the West bank of the North Saluda River at Station 249 plus 71.8 of the survey of the North Saluda Reservoir pipe line and runs thence through the property of Sallie Hood, S. 1-09 W., 1089 feet, more or less, to PI, Station 260 plus 60.4 (FWD) and Station 260 plus 60.8 (BK); thence still through the property of Sallie Hood, S. 16-15 W. 28.2 feet to Station 260 plus 88.6 of the survey which point is in the Southern boundary line of the Sallie Hood tract at a point 385 feet, more or less, in an Eastern direction from an iron pin, corner of the said tract.

The property affected by this right of way and easement is the same conveyed to Sallie Hood, William H. Hood and Walter B. Hood, by deed of G. L. Hood, dated June 20, 1918, recorded in the RMC Office for Greenville County, S. C., in Deed Book 44, page 451.

and to construct and maintain in, upon and through said premises, in a proper manner, a pipe line or lines, air vents, blow off connections, manholes and other necessary apparatus incident thereto, using the necessary appliances and machinery for such work for the purpose of conveying water through the premises above described, together with the right at all times to enter upon said premises for the purpose of inspecting said line or lines and making necessary repairs and alterations thereon, together with the right to cut away and keep clear of said pipe line or lines all trees and other obstructions that may in any way endanger or interfere with the proper operation of or access to the same.

It is understood and agreed that the right of way to be used under this contract during construction is to be seventy-five feet in width throughout the entire length which is approximately 1117.2 feet, and the damage, which The City of Greenville, South Carolina, is to be liable for during construction, is to be confined to this strip and nothing beyond. The location of the pipe line or lines, when laid, will determine the definite location of the right of way. The center of the pipe line or lines shall be accepted as lying twenty-five feet from the West boundary line of this right of way. The remaining fifty feet of said right of way during construction shall lie East of the center of said pipe line or lines and the entire right of way may be used for the purpose of installing the pipe line or lines. The location of said pipe line or lines is to be approximately along the line as now located and staked out by the engineers, subject to a variation of not exceeding five feet either way. The permanent right of way, after the pipe line or lines are installed, shall be fifty feet in width measuring twenty-five feet from the center on each side of said pipe line as laid, and no obstruction shall hereafter be placed on said fifty foot right of way.

If in laying the pipe line or lines, it is necessary to cut any timber from the right of way, such timber shall be placed at the edge of the right of way on the land of the landowners and shall be the property of the landowner.
