to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Eugene Rackley, his heirs and assigns, forever:

All that piece, parcel or lot of land situate, lying and being in Greenville County, South Carolina, and being shown as Lot No. 89 on a plat of Western Hills recorded in the R. M. C. Office in Plat Book QQ, pages 98-9, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the westerly side of Laramie Drive, at the joint front corner of Lots Nos. 88 and 89, and running thence with the common line of said lots S. 58-45 W. 132.8 feet to an iron pin; thence N. 19-40 W. 160 feet to an iron pin on the southerly side of Tucson Drive; thence with the southerly side of Tucson Drive, N. 65-20 E. 75 feet to an iron pin; thence around the curve of the intersection of Tucson Drive and Laramie Drive, the chord of which is S. 75-30 E. 36 feet to an iron pin on the westerly side of Laramie Drive; thence with said Drive, S. 36-13 E. 97.5 feet to an iron pin; thence S. 35-25 E. 25 feet to the point of beginning.

The above described lot is conveyed subject to the recorded restrictions applicable to Western Hills, and to the easements, rights-of-way and set-back line as shown on said plat.
