BEGINNING at an iron pin on south east side of Arlen Ave., at corner of lot No. 3, and running thence along line of lot No. 3, S. 36-06 E. 118.4 feet to an iron pin; thence S. 55-47 W. 257.85 feet to an iron pin on Garrison Road; thence along Garrison road, N. 2-40 W. 131.5 ft. to an iron pin on Arlen Ave.; thence along Arlen Ave., N. 53-54 E. 185 feet to the beginning corner.

The above described lot is conveyed subject to the following restrictions:

1- No building is to be erected or used for commerical purposes on said lot.

- 2- Any dwelling erected on said lot shall be at least 25 feet from property line of street on which said lot fronts.
- 3- Any dwelling erected on said lot shall contain at least 1200 sq. feet of floor space on the first floor exclusive of poarches and garage; shall cost a minimum of \$ 10,000.00; shall be completed before being occupied; and shall be equipped with a satisfactory septic tank or connected to a sewer;
- 4- No outbuilding with the exception of a garage shall be erected within 60 feet of the street on which said lot fronts.
- 5- No goats or pigs are to be kept on said lot.
- 6- Any fences erected shall be at least 60 feet from the property line of the street on which the lot fronts.
