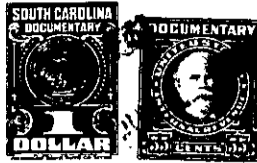

unto **Roy D. Woods and Eleanor L. Woods, their heirs and assigns forever:**

ALL that piece, parcel or lot of land, in the State and County aforesaid, being known and designated as Lot No. 214, as shown on a Plat of Section No. 2, Caroline Court, dated November 1953 by Dalton & Neves Engineers, recorded in the R. M. C. Office for Greenville County in Plat Book GG, at Page 21, and having according to said plat the following metes and bounds, to-wit:
