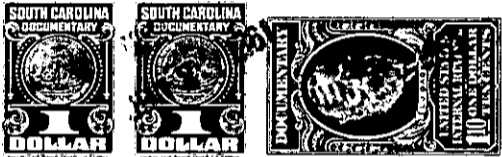
Know All Men by These Presents:

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipts whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Katherine R. Barton, her heirs and assigns:

All that piece, parcel or lot of land situate, lying and being near the City of Greenville, County of Greenville, State of South Carolina, and known and designated as lot #38, part of Avon Park, as shown on plat prepared by C. C. Jones, Engineer, dated December 1956, and recorded in the R.M.C. Office for Greenville County in Plat Book KK, at Page 71, and according to said plat having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the western edge of Thames Drive, the joint front corner of lots #38 and #37, and running thence along the line of these lots, S. 69-51 W. 207.9 feet to an iron pin in the line of lot #30; running thence N. 24-14 W. 26.7 feet to an iron pin; thence N. 2-50 W. 101.2 feet to an iron pin at the joint rear corner of lots #38 and #39; running thence N. 81-26 E. 190.6 feet to an iron pin on the western edge of Thames Drive; thence along Thames Drive, which line is curved, the chord of which is S. 14-19 E. 67.1 feet to an iron pin; thence continuing along the western edge of Thames Drive, S. 20-09 E. 17.8 feet to an iron pin, point of beginning.
