"ALL that piece, parcel or lot of land situate, lying and being in Gantt Township, Greenville County, State of South Carolina, and being known and designated as Lot No. 262 and 263 on a plat of a subdivision known as Augusta Acres, property of Marsmen, Inc., plat of which is recorded in the R.M. C. Office for Greenville County, South Carolina, and has the following metes and bounds, to-wit: BEGINNING at the point front corner of Lots 264 and 263, on the western side of Meadors Avenue and running thence S 5-57 E 110 feet; thence on the same course 82 feet; thence S 1-49 W 38 feet to the joint corner of Lots 261 and 262; running thence N 87-32 W 250.5 feet to an iron pin; thence N 3-57 W 175.9 feet to an iron pin; thence N 80-01 E 240.8 feet to the BEGINNING corner; being the same land conveyed to Johnnie J.
