KNOW ALL MEN BY THESE PRESENTS That WILKINS NORWOOD & COMPANY, INC.

a corporation chartered under the laws of the State of South Carolina and having its principal place of business at Greenville, in the State of South Carolina, for and in consideration of the

sum of Two Thousand, Three Hundred - - - - - (\$2,300.00) - - - - - dollars, to it in hand duly paid at and before the sealing and delivery of these presents by the grantee(s) hereinafter named, (the receipt whereof is hereby acknowledged), has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto ROBERT W. RAMSEY:

All that piece, parcel or lot of land situate, lying and being on the Northern side of Vicki Circle in the County of Greenville, State of South Carolina, being known and designated as Lot No. 16 as shown on Plat No. Three, Cherokee Forest, prepared by J. Mac Richardson, R. L. S., in January, 1959, and recorded in the R. M. C. Office for Greenville County, South Carolina, in Plat Book QQ at pages 36 and 37, and having according to said plat, the following metes and bounds:

BEGINNING at an iron pin on the Northern side of Vicki Circle at the joint front corner of Lots Nos. 16 and 17 and running thence with the line of Lot No. 17 N. 4-31 E., 200 feet to an iron pin in the subdivision property line; thence with the said subdivision property line N. 85-29 W., 294.4 feet to an iron pin in or near the center of a branch and at the joint rear corner of Lots Nos. 15 and 16; thence with the center line of said branch as the line (and with the line of Lot No. 15) having a traverse line as follows: S. 40-20 E. 130.1 feet to an iron pin, S. 59-59 E. 80.5 feet to an iron pin, S. 29-06 E. 87.5 feet to an iron pin on the Northern side of Vicki Circle; thence with the Northern side of Vicki Circle S. 85-29 E. 80 feet to the point of beginning.

The premises hereinabove described are subject to a drainage easement 5 feet in width along the branch as shown on the plat referred to hereinabove.

This is a portion of the property conveyed to the Grantor herein by deed of Lucile L. Smith, et al, dated September 15, 1959, and recorded in the R. M. C. Office for Greenville County, South Carolina, in Deed Book 634 at page 188.



Together with all and singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging or in anywise incident or appertaining.

To have and to hold all and singular the premises before mentioned unto the grantee(s) hereinabove named, his successors, heirs and assigns forever.

And the said granting corporation does hereby bind itself and its successors to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and his successors, heirs and assigns, against itself and its successors, and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
