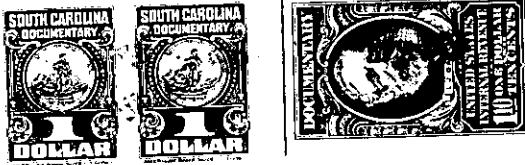
That I, Horace P. Baumgardner, as Trustee,

H. Mauldin, his heirs and assigns forever:

All that certain piece, parcel, or lot of land situate, lying and being in the State of South Carolina, County of Greenville, Chick Springs Township, being known and designated as Lot No. 34 of a subdivision known as Dogwood Terrace as shown on plat thereof prepared by J. Mac Richardson, R. L. S., May, 1960 and recorded in the R. M. C. office for Greenville County in Plat Book UU, at page 5, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the western edge of Sylvania Drive, joint front corner of Lots 33 and 34, and running thence along the joint line of said lots, S. 58-08 W. 159.9 feet to an iron pin, the joint rear corner of said lots; thence N. 32-42 W. 97.4 feet to an iron pin at a rear corner of Lot 35; thence along the rear lines of Lots 35 and 36, N. 57-18 E. 184 feet to an iron pin on the western edge of Sylvania Drive; thence along the western edge of Sylvania Drive, S. 19-45 E. 52.3 feet to an iron pin; thence continuing along the western edge of Sylvania Drive, S. 18-05 E. 50 feet to the beginning corner; being a portion of the property conveyed to me by W. T. Bidwell, et al. by deed dated November 14, 1959 and recorded in the R. M. C. office for Greenville County in Deed Vol. 639, at page 1.
