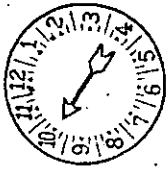

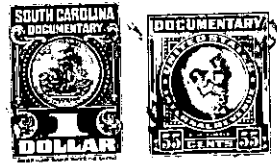
KNOW ALL MEN BY THESE PRESENTS, that **LEBRE ENTERPRISES, A SOUTH CAROLINA CORPORATION**
