Watson), brothers, (and to gether with our mother, Buena Vista Watson, widow of John H. Watson and the Grantee hereinaf er, being the sole heirs at laward next of kin of John H. Watson, deceased, who died intestate on the 14th day of January, 1944, being at the time of his death a resident of Fitzgerald, Ben Hill County, Georgia) in the State aforesaid, for and in consideration of the sum of One and no/100 DCLLARS, to us in hand paid at and before the sealing of these Presents, by Buena Vista Watson, in the State afore said (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto said Buena Vista Watson, her Heirs and Assigns, forever the f llowing described real estate, to wit:

All of our right title and interest in that certain piece, parcel or tract of land lying, being and situate in the First Ward of the City of Greenville, Green ville County, State of Scuth Carolina, at the Southwest corner of Buncombe Street and Frank Street, and more particularly described as follows.
