All that certain piece, parcel or lot of land; lying and being on the northerly side of East Heathwood Drive at the northeasterly corner of its intersection with Heathwood Drive, near the town of Taylors, S. C., being shown as Lot No. 8 on the Plat of Heathwood as recorded in the RMC Office for Greenville County S. C. in Plat Book KK, page 35 and having according to said plat the following metes and bounds to-wit:

Beginning at an iron pin on the northerly side of East Heathwood Drive, joint front corner of Lots Nos. 8 and 9 and running thence along the joint line of said lots N 15 - 39 E 181.2 feet to an iron pin; thence with joint line of Lot No. 5 N 74 - 27 W 94 feet to an iron pin on the easterly side of Heathwood Drive; thence with the easterly side of Heathwood Drive S 17 - 33 W 158 feet to an iron pin at the intersection of said Drive with East Heathwood Drive; thence around said intersection on a curve the chord of which is S 28 - 58 E 34.5 feet to an iron pin on the north side of East Heathwood Drive; thence with the north side of East Heathwood Drive S 75 - 29 E 75 feet to the point of beginning.
