(the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said R. C. Collins, his heirs and assigns, forever:

ALL that lot of land on the North side of a County Road, near the City of Greenville, in Butler Township, in Greenville County, South Carolina, being shown as Lot No.1 on plat of property of Lucy L. Hindman made by W.J. Riddle, Surveyor, October 1939, recorded in the R.M.C.
