KNOW ALL MEN BY THESE PRESENTS, that I, Samuel Claude Pop

in consideration of Four Thousand Five Hundred (\$4,500.00) Dollars,
and assumption of mortgage
the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release
unto Lloyd W. Gilstrap, his heirs and assigns forever:

All that piece, parcel, or lot of land in Greenville County, South Carolina being known and designated as a portion of Lots No. 18 and 19 of Farr Estates according to plat recorded in the Office for the R. M. C. for Greenville in Plat Book L at page 131 and having according to the survey made by J. C. Hill, Engineer on November 26, 1954, the following metes and bounds to-wit:

BEGINNING at an iron pin at the Northside of Putman Road joint corner of Lots No. 19 and 20 and running thence along Putman Road N. 84-30 E. 122 feet to an iron pin; thence N. 5-30 W. 152.8 feet to an iron pin which iron pin is 8 feet more or less from the center of a branch; thence to the center of said branch and up the meanders of said branch 212 feet to a point 22 feet more or less from an iron pin; thence from said iron pin S. 31.0 E. 174 feet to an iron pin the point of beginning containing .61 acres more or less and being a portion of the property conveyed to the Grantor by deed of J. C. Pridmore.

It is expressly understood and agreed that the Grantor, her heirs and assigns, shall have a right of way 15 feet in width along the Western boundary of this property from Putman Road to the rear of the property above described for use as a driveway.

The Grantee herein expressly assumes and agrees to pay the balance due on that certain Mortgage executed to Fidelity Federal Savings & Loan, the present balance due being the sum of \$9,500.00; Recorded in Mortgage Book 641 at page 71.
