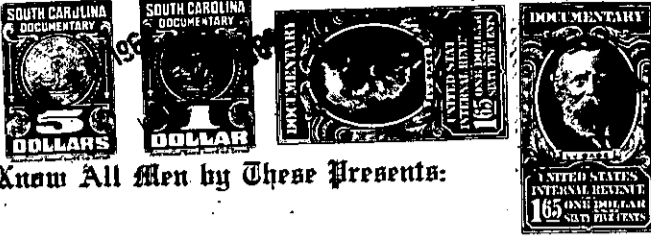

All that lot of land in the county of Greenville, state of South Carolina, being shown as Lot No. 12 of Block G on a plat of Fair Heights recorded in Plat Book F at page 257 and being more particularly described according to a recent survey by R. W. Dalton, November 1950 as follows:

Beginning at a stake on the eastern side of Cumberland Avenue 250 feet northeast of the intersection of Cumberland Avenue and Decatur Street, joint front corner of Lots 12 and 13, and running thence with said Cumberland Avenue N. 31-20 E. 50 feet to a stake, joint front corner lots 11 and 12; thence with the joint line of said lots S. 58-40 E. 150 feet to an iron pin in line of Lot 23; thence with the line of said lot S. 31-20 W. 50 feet to an iron pin, joint rear corner lots 12 and 13; thence with the joint line of said lots N. 58-48 W. 150 feet to the point of beginning.

This is the same property conveyed to grantor by Constance Margaus Putman and Thomas E. Putman by deed recorded November 15, 1950 in deed volume 423 page 229 of the RMC Office for Greenville County.

The grantee herein assumes and agrees to pay that certain mortgage held by Prudential Insurance Company of America recorded in mortgage volume 483 page 189 of the RMC Office for Greenville County, on which there is a balance due of \$3,747.64.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining.

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and his Heirs and Assigns forever.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s) Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s) Heirs and Assigns against the grantor(s) and the grantor's(s) Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
